4. Report from K-12 Executive Director

K-12 students participated in Pink Shirt Day on February 24, 2016. Seniors were divided among the lower school classrooms. Each group read a story and had the lower school students complete different projects around anti-bullying. While this was going on, middle school students participated in various rotations with the upper school students also around anti-bullying efforts. Overall, it was a successful day.

Hoboken Charter School, in collaboration with Stevens Cooperative School and Elysian Charter School, hosted a free parent education workshop titled "Helping Your Child/Teen Navigate Tough Choices" on March 1st. Presenters shared with parents the latest research, information and tools to effectively communicate with their children around challenging issues, such as drug and alcohol abuse, responding to peer pressure and risky behaviors. The workshop focused on how parents can initiate challenging conversations and equip their children with the skills to manage increasingly complex social dynamics and situations. Many thanks to Lauren Freylikhman for coordinating.

5. Report from Lower and Middle School Principal

On 3/1 afternoon, several teachers and administrators from the lower and middle school participated in a workshop focusing on mindfulness in the classroom. Marti Austin of WeeCare Associates guided the group through chair yoga poses and guided meditations that can be used in the classroom with students of all ages. Current research on this topic suggests mindfulness can positively impact classroom dynamics in terms of improving student attention, reducing anxiety, increased self-regulation and calmer learning environments. Many thanks to Melissa Fisher for coordinating.

A lot of great stuff has been happening in and out of the art room! The Steampunkers 4th-6th grade after school group has created some substantial work. The middle school Monkey Business group is busy with their Save the Lion campaign and did a terrific awareness workshop with the first grade students. They'll also be volunteering at the Woodstock Farm Animal Sanctuary on the March19, 2016. Also the third grade Ubuntu kids are busy preparing Water Wings for March 12, 2016, at St. Matt's to bring clean water to kids in Africa. Additionally, Mr. Duff will be speaking with the Chamber of Commerce on March 15, 2016 about the HCS service learning program.

Fourth grade took a trip to the State House in Trenton where they had a guided tour and had time at the NJ State Museum. This trip is mostly funded by a small grants program which Ms. Swentzel applied for that provides awards of up to \$350 to eligible middle-school and high-school teachers of government, civics, history, and other social studies classes. The grants are designed to help pay for bus rental costs to take classes on field trips to the State House in Trenton for special guided tours and first-hand examination of the legislature's role in our system of representative democracy.

A teacher artist from Lincoln Center worked with third and fourth graders on March 1, 2016, in preparation for a concert at Lincoln Center being held on March 10, 2016.



6. Report from Upper School Principal

- I. Congratulations to our Varsity Boys' Basketball team for a great year and, the first time in school history, qualifying for the NJSIAA Boys Basketball state tournament.
- II. Congratulations to our Varsity Boys Basketball team for winning the end of the year Charter School Athletic League tournament.
- III. One of our Upper School students, junior Rozlin Hall, will be receiving a State Art Award from The Art Educators of NJ in Trenton. The awards ceremony will take place on March 11th.
- IV. The Upper School has been invited to paint a mural in the new teen space of the Multi-Purpose Center on Grand Street.
- V. In conjunction with over fifteen local community partners, our Upper School seniors are continuing their work with their capstone service learning projects.
- VI. Our Upper School's student run "Spear Your Career" club hosted their second guest speaker. This month's speaker was Abbe Rivers, singer, actress, and owner of Empire Coffee.
- VII. The Upper School is participating in the "Students Rebuild Healing Classroom Project". This project will allow our Upper School students to work closely with students from our Lower School and from HOLA to better understand the plight of child refugees living in war-torn areas.
- VIII. This past week seventeen of our Upper School students went to see Blue Man Group in the city. Special thanks to High 5 and Teen Connection for donating these tickets.

Freshman Valentina Sacaridis and Gabby Price will be designing the sketch, and seniors D'Angelo Barrow and Ivan Sanchez will be leading the project as part of their senior portfolio.

 - XI. In recognition of Black History month, the Upper School students contributed over 50 portraits to the city of Hoboken's display at City Hall.
