# 5. <u>Report from Lower and Middle School Principal</u>

The middle school dance was held on Friday, April 8 at Room 84 in Hoboken with the theme of "New York, New York". A special thanks to the Parents Association for coordinating the event, with the help of Mr. Persico and the Student Government.



The Third Grade class is partnering with the Hoboken Green Team to complete the Storm Drain Mural Project. This project raises awareness about water pollution, as students will paint environmentally themed murals on and around storm drains. They have done research on the causes of water pollution and the effects of storm drain contamination. All of their hard work has culminated into 2 storm drain sketches, which indicate that all drains empty to waterways. The third graders will paint their murals on Monday, April 18 at two nearby locations - 7th and Washington and 6th and Washington. Please see the attached sketches to see what they will be painting.
