5. Report from Lower and Middle School Principal

Out of more than 200 entries in the junior category, Toby Platt was named one of four finalists in the Future Engineers Star Trek Replicator Challenge. The challenge, developed in conjunction with NASA, was to create a digital 3D model for a non-edible, food related item that astronauts could 3D print in space. Through his enrichment engineering elective with Mr. Kunkel, he created a water condenser to allow for drinking water to be collected from the air during space missions. As a finalist, Toby, a rising sixth grader, was awarded a PancakeBot for his family and a MakerBot Replicator Mini for Hoboken Charter School. Toby's design was judged based on his innovation, creativity, model quality and presentation.
