# **Upper School Report**

On October 11th, the HCS-Upper School 9th, 10th, and 11th graders took the PSAT exam. Results will be made available in the spring.

On October 12th, the HCS-Upper School hosted its fall Open House. This Open House provided us with an opportunity to meet with prospective families and discuss how our Upper School can best meet their child's academic, social, and emotional needs.

On September 27th, the Upper School hosted its annual "Back-to-School" night. This evening was well attended and provided parents with an opportunity to meet their child's teachers and here about the educational programming that the Upper School has to offer.

On September 27th, Ms. Ryan (HCS School Counselor) hosted a Financial Aid night for our Upper School parents. Ms. Ryan had a representative from the Higher Education Student Assistance Authority (HESAA) come to discuss financial aid options and the application process. In addition to the Financial Aid night, Ms. Ryan has met with all of the seniors and their parents to touch base and assist with college/career planning.

In recognition of "Indigenous People's Day", the Upper School staff has designed many meaningful learning experiences centered on changing the practice of celebrating Christopher Columbus to a practice of celebrating indigenous peoples' presence, endurance and accomplishments.

In recognition of the "Week of Respect", Ms. Heather DeSimone and the Upper School's advisory groups completed a "respect" banner. Each advisory group received one or two large bubble letters, which spelled out "HCS Respects!" when put together. Each student wrote at least one example of what respect means to them in the bubble letter. The banner is displayed in our student lounge area at the Upper School. The week culminated with a "gallery walk" around the school in which both students and staff could see student artwork and poems centered on the themes of respect and anti-bullying.

During the month of September, the Upper School's service learning club, GenerationOn, had been collecting donations (food, toiletries, clothing, etc.) to assist families and individuals in Puerto Rico who were affected by Hurricane Maria. Our students have been working with Ms. Ida Cruz, who is running the drive at the Hoboken Multi-Service Center. Mr. Persico, Ms. Diaz, and the eighth-grade students have been assisting the Upper School with the sorting and packing of the donated items.

# **Lower School/Middle School Administrative Reports**

On Thursday, October 5 several members of the HCS Middle School Girls Who Code (GWC) club attended a program, "Solve For XX: A Celebration of Women in Mathematics" at the Museum of Mathematics in New York City. At the event, students heard a presentation from Anousheh Ansari, the first civilian woman in space. Students not only got hear her incredible life story, but meet her as well.

Tuesday, October 10 brought together much of the academic exploration our K-12 students have been engaged with over the course of the first month of school, as we hosted two assemblies (one for Lower School and one for Middle/Upper School) in celebration of Indigenous People's Day. Irka Mateo, a Tiano descendent put on a performance for both groups. Leading up to this celebration, our Lower School classes focused on learning more about several indigenous tribes. In fourth grade, students connected this to much of their work with the Lenape tribe and our mission of social justice by writing persuasive letters to the Bureau of Indian Affairs explaining why the Lenape deserve to be granted status as a tribe. In Middle School, students explored the idea of discovery and examined the importance of learning history from multiple perspectives. In seventh grade, students focused on the idea multiple perspectives, with students writing "two-voiced poems" - one from the perspective of Native Americans and one from the perspective of the Europeans.

Lower and Middle School students have been focusing on doing their part for the environment. Our second and third grade students have been raising awareness around recycling. They have been labeling recycling bins and garbage cans and visiting each homeroom to review what materials can and cannot be recycled. Additionally, the seventh grade have begun a composting initiative through science class with Ms. Mitchell.

One of our Lower and Middle School classes participated in experiential field trips outside of the classroom:
