**Executive Director’s Report**

The Special Education Parent Advisory Meeting hosted a session with local Art Therapist, Jodi Goldberg, on November 29. Ms. Goldberg shared various examples of student work and provided attendees with therapeutic strategies to support students experiencing difficulties with social, emotional and behavioral functioning in the home and school settings. We look forward to continuing a collaborative relationship with Ms. Goldberg.

The Hoboken Charter School Middle and Upper School Robotics Team “Roboken” competed on Saturday, December 2 at the Winter’s Edge Meet held at Central Jersey College Prep Charter School. The team finished 6th during the qualifying rounds, moving on to the elimination round. The team, along with their alliance partner, made it to the finals and won the meet. Roboken will be moving on to their first state qualifier meet on Saturday, December 9, which will determine eligibility for the state tournament. Congratulations to Roboken and their advisors Mr. Kunkel and Mr. Greif.

### **Upper School Report**

Ms. Addona's 11th and 12th grade English classes will be partnering with the Hoboken Historical Museum for their "Poetry in Schools" program again to work with one of their teaching artists to write, publish, and perform their poetry at a public reading.

The HCS Robotics team (Roboken) competed at the Central Jersey College Prep Charter School competition on December 2nd. Our team (in alliance with two other teams) took home the top honors. Congratulations to all of the HCS students that competed.

During the month of November, the HCS Upper School's service-learning club GenerationOn ran a canned food drive. All food and donations that were collected were donated to St. Matthew's lunchtime food program.

On Monday, December 11th the members of the Upper School Girls Who Code Club joined the Lower/Middle School students for The Hour of Code - a global movement reaching tens of millions of students in 180+ countries. The young women from the upper school served as room 'captains' for the younger students.

### **Lower School/Middle School Administrative Reports**

Hoboken Charter School Middle and Upper School students were recently profiled in the Hudson Reporter for their work to raise money to send two generators to Puerto Rico in response to the damage caused by Hurricane Maria.

The Lower School performances of *Willy Wonka Kids* were held on Friday, December 8 and Saturday, December 9. The Middle School will begin auditions for their Drama Club production of "Seussical the Musical" later on in December.

On December 11, the HCS Upper and Middle School "Girls Who Code" programs participated in the annual Hour of Code event taking place during Computer Science Education Week. The 6th-8th grade and Upper School teams will invite 3rd-5th grade girls to join them to learn more about coding and the projects they've been working on through the club. This work by Mr. Kunkel and the Girls Who Code program were highlighted by littleBits in a press release.
