Executive Director Report

Over the past few weeks, HCS students learned about the world water crisis and ways in which they can be agents for positive change. A K-12 Water Walk for H2O for Life raised a grand total of \$9,126.25 specifically to benefit our commitment to the water and sanitation projects at Ikoli Primary School in western Kenya.

On Tuesday, April 30, Upper School students visited the first grade class to read the book, *Fly Away Home* with students as a part of their service project to collect toiletries for the Hoboken Shelter.

On Friday, May 3, Upper School senior Hanene Gomma did a component of her senior project with our fifth and seventh grade girls. The project focused on girls' empowerment and self-esteem.

Lower School/Middle School Report

The second grade class hosted publishing parties to celebrate their end of unit writing projects. The class wrote informational texts about a topic of their choice.

The Middle School had their annual dance on Friday, May 10 at HOPES.

The Girls on the Run club ran their 5K in Sparta, NJ on Saturday, May 11.

On Tuesday, May 14, the sixth graders hosted a speaker with from CASA (Court Appointed Special Advocates) to learn more about their work with children who experience abuse and neglect as a tie-in to their current novel, *The War That Saved My Life*.



On Friday, May 17, the Middle School bands (5/6 band, 7/8 band and Jazz Band) performed at the High Notes Music Festival in Allentown, PA. The Middle School then enjoyed the day at Dorney Park.

Several of our Lower and Middle School classes have participated in experiential field trips outside of the classroom:

- The fifth grade went to the Hudson River to observe a fish dissection and fish in the Hudson
- The seventh and eighth grade environmental science elective students went to the Hoboken Cove to find and analyze organisms
- The kindergarten visited Mile Square theater to see *Bunnicula*
- The first and second grade classes visited Carnegie Hall
- The kindergarten and first grade classes went to see *Charlotte's Web*

Middle School science teacher Evangelina Pena was selected to participate in New Jersey School of Conservation Teaching Scholars program this summer through Montclair State University. The program is for middle school teachers and focuses on biodiversity field methods.

The Upper School is also using data to improve our support network for students graduating from Hoboken Charter School.
