# 9. <u>K-12 Report</u>

Our World History students studied period poverty worldwide and specifically Bill A3388, which will provide access to free menstrual products in all public schools in New Jersey. They then worked with representatives from The Flow Initiative to package over 10,000 period products for people in need. The 11<sup>th</sup> graders then met with Mr. Kunkel's 7<sup>th</sup> graders to discuss their work, augmenting the 7<sup>th</sup> graders' study of the Pink Tax in connection with exploring unit rate in math class.

HCS held a second vaccine clinic during the school day for our students aged 5-11.

HCS released a school Facebook page which will highlight the school experience at HCS as well as promote charter advocacy and dispel myths around charter schools.

Representatives from three Hoboken charter schools (board members, parents and administrators) have been meeting to address charter advocacy efforts.

Deirdra Grode has been participating in a Community of Practice with charter leaders from around the country committed to equity to discuss ways in which we can accelerate learning to address learning loss via intentional scaffolding, building knowledge and vocabulary, prioritizing standards, modifying guided reading, diagnosing essential missed learning and incorporating text sets.

# 10. Lower/Middle School Report

On Saturday, November 20, HCS had four teams compete in the virtual FIRST Lego League Robotics competition.

- Coding Cougars 8<sup>th</sup> graders
- CouGears mixed 4<sup>th</sup> to 6<sup>th</sup> grade
- Roboken 5<sup>th</sup> graders
- Robotic Llamas Jr 4<sup>th</sup> graders

There were 24 teams participating. For the robot results, the top scorers were the Robotic Llamas in 5th place followed closely by the CouGears in 6th. The Robotic Llamas received the breakthrough award. And a special congratulations to robotics advisor Mr. Kunkel who was recognized by the First Lego League as the Mentor of the Year.

On Monday and Tuesday December 6 and 7, Middle School Artsbridge students participated in their end of trimester share session. Offerings in the fall included world drumming, craftivism, improvisation and acting.

On Wednesday, December 15, the K-8 music program, led by Mr. Gavarny, hosted their first in person winter concert in two years at All Saints. Performances included the K-3 singers, the fourth graders on the recorder, the 5/6 and 7/8 concert bands, and the jazz band.

Over the weekend of December 18, the third, fourth and fifth graders performed *The Jungle Book* at the Hoboken Children's Theater, led by director Mr. Persico.

To kick off this holiday season, the fourth graders have teamed up with The Leukemia & Lymphoma Society (LLS) in their "Light the Night" campaign for the fourth year in a row. During this two week campaign, students are part of a "Hero Squad," raising money in whatever way they can for patients with blood cancers, many of them being children just like themselves. Simultaneously, students are participating in Common Core STEM lessons, with a focus on learning about cells to inspire students to be scientists working toward a cure, as well as a social emotional learning curriculum to teach empathy and other important skills. Their campaign is now running until Friday, December 17th. The fourth graders have ambitiously set their goal at \$15,000, having raised over \$12,000 in the first week.

Both the Lower and Middle School Student Government Associations held their executive board and class representative elections.

New elective and Artsbridge classes began for the second trimester. Elective offerings include sustainable fashion, machines and Minecraft, yearbook, technology student association (TSA) and wiz kids. Artsbridge offerings include music tech, beginning monologues, intermediate acting, mural design and guitar.

The fifth grade class led a board game donation as a part of their reading of *The Breadwinner*, which focuses on life in Afghanistan under the Taliban. The board games will be donated to Afghani refugee families starting their lives in the United States.

# 11. Upper School Report

In an ongoing effort to support our Juniors and Seniors stay on the path towards post-secondary plans, we

hosted the ASVAB, a test that can be used by students considering the military as well as students looking to pass their graduation testing requirement. In an effort to rebuild community, our Seniors worked with their advisor to organize a Friendsgiving event as well as a Bake Sale to raise money towards their end of year events.

Upper School staff have been specifically focusing on curriculum this year. While working with Sara Wicht on Social Justice and Service Learning, we took time to consider the Learner Centered aspects of our curricula. Teachers spent time in departments reviewing the updated 2020NJSLS with an eye to prioritizing and vertical alignment across the grades.

Cheer and Basketball teams have begun practice with an eye to the 2022 season!
