9. K-12 Report

Over the February, break HCS's two FIRST Tech Challenge teams competed in their League Tournament. This event was the culmination of a season's worth of meets. Both teams did a fantastic job! Roboken, our team with 8th to 12th graders, ended the day as the 4th ranked captain out of 23 teams. They were able to form an alliance with two other teams and compete in the elimination bracket. Unfortunately, they were eliminated in semi-finals. However, they still advanced to the State Championship via judging. They impressed the judges with and earned the Innovative Award for their unique drive train.

The Robotic Llamas, our 7th grade team, ended the day as the 2nd ranked captain and made it all the way to finals. In finals they were eliminated by the same team that took out Roboken, but because they made it that far, they earned a place at states. They also impressed the judges. They were the third place Inspire Award winner, which also would have advanced them to states had they not already made it via robot play. The Inspire award is given to the teams who do well in all judging categories and is very prestigious. Finally, they won the Control Award for their strong coding. It was a very, very impressive performance.

Both teams will be competing in the state championship this coming weekend. Congratulations to the teams and their advisor, Mr. Kunkel!

On Tuesday, March 8, grades 5-7 and 9-11 met with Mykee Fowlin, an actor and motivation speaker, whose presentation uses a variety of acting and psychological techniques aimed to promote inclusivity and acceptance of differences.

Thanks to the K8 basketball teams' donation of time at the 605 Jackson St gym, the Winter Team sports were able to hold a Senior Night. The boys and girls basketball teams played against each other in a friendly match as everyone celebrated our Senior Basketball and Cheer Team members.

The city is now allowing our PE classes to use gym space for physical education classes. Tuesdays, classes will walk .7 miles to the Multi Service Center gym and Thursdays they will walk .6 miles to the 605 Jackson St gym. They even get a workout on the way to and from class!

March 14-18th, the 11th graders will be taking the New Jersey Graduation Proficiency Assessment, a new test students must pass for graduation. Students have been practicing the test format in class and a free after school review class was offered.
