9. <u>K-12 Report</u>

HCS participated in its charter renewal site visit on October 26, 2021 which became a virtual visit due to the storm and State of Emergency. Representatives from the NJDOE met with student, parent, administration, board of trustees and teacher groups for interviews and conducted virtual classroom observations. The day was a success and in the end of day debrief, the NJDOE shared that they observed evidence of our mission in action throughout the entirety of the school's presentation.

HCS and the Friends of HCS have partnered to conduct a survey of the HCS parent community to assess areas of expertise and interest in supporting the HCS community through professional skills including, but not limited to, web design, social media, finance, grant writing, alumni affairs, communications, etc. We also assessed interest in serving as a professional mentor to an upper school student. 27 parents have completed the form to date and we are finding a great deal of interest and a wide variety of expertise.

HCS hosted its first pediatric COVID-19 vaccine clinic today for HCS students of ages 5-11. Staff were also able to receive their booster and students 12 and up were able to get vaccinated as well.

10. Lower/Middle School Report

The 5th grade is organizing a game drive for Afghan refugees in conjunction with their novel study of the book *The Breadwinner*.

Various grades studied Diawali and parents participated by joining students in the courtyard to share in the festivities and present on their family traditions.

3rd graders just wrapped up a SS unit called Land of the Free: Indigenous People and Columbus/Colonization, which culminated in a social action project where they petitioned city hall to include representation of indgenous culture at Columbus Park in Hoboken.

11. Upper School Report

Teachers took advantage of the beautiful fall to schedule some field trips. The Flags and Protest Signs elective visited the Whitney Museum of Art to see examples of the use of the American flag in protest art. The Hudson River Biology class spent time outside for a Habitat Diversity lab.

With the ending of the first marking period, we are transitioning to new electives. Marking period 2 includes courses focusing on activist tools such as Art Journaling, Filmmaking, and Acting as Activism. Another course explores career opportunities in the field of Sports. All 10th graders will be taking Explorations. The Exploration course seeks to build research and writing skills as students explore an area about which they are passionate. This course allows students to explore and develop their individual interests through a comprehensive project involving research and creativity. Students will connect personal interests to the greater society through social justice themes.

Our College and Career Counselor has coordinated a number of visits and workshops for the Seniors. We have welcomed NJCU, Saint Elizabeth University, Montclair State University, Fairleigh Dickinson University, University Technical Institute, Army National Guard, and Rowan University. In addition, Ms. Polak and a representative from HESAA led Seniors and their families through a workshop on filling out the FAFSA- an important form for college financial aid.

Thanks to donations from K-12 families through coordination of the Friends, as well as the efforts of the Ambassadors with Ms. Curtin's leadership, we held a very successful Halloween dance.
