13. **K-12 Report**

- HCS completed and submitted the Building Hope Student Empowerment IMPACT Grant Application that would support efforts to support the creation of Mission Week and support increased alumni connections. Finalists are expected to be announced this week.
- Upper School seniors met with the fourth-grade class at Elysian Park to discuss being an upstander.
- The kindergarten class and students in Espanol 1 came together for a Dia de Primavera "Spring Day" Event. Upper School students taught kindergarteners about Compassion, Life Cycle of a Butterfly, Water Cycle, Composting and Fruits and Vegetables in Spanish. Kindergarteners in turn taught Upper School Students many fun Spanish songs and dances.
- The Black Student Alliance, consisting of students in the middle school with upper school mentors and under the supervision of Mr. K-Z, meet weekly to hang out, talk about social issues (e.g., colorism and its contributions to racism within the Black community) and create art.

14. <u>Lower/Middle School Report</u>

There have been a number of inter-age experiences over the last month:

- Fourth graders sharpened their Spanish skills by playing board games created by the eighth graders.
- Fourth graders visit the seventh-grade math class for their Carnival of Probability.

Seventh and eighth grade students have partnered with the Ukrainian Community Center of Jersey City to collect donations for Ukrainian Refugees. Students also engaged in a formal business letter writing campaign as outreach to other schools in the community. HCS also partnered with the Hoboken Community Center Pantry for a personal care supply drive during the week of April 4-8.

On Wednesday, March 23, the fifth-grade class showcased their social studies projects for families and Lower School students in which they created civilizations based on their study of Ancient Mesopotamia.

On Tuesday, March 29, 35 Middle School students attended the Trimester 2 Cornerstone Award luncheon. Students applied for recognition based on demonstrated academic, personal, civic (social justice) or artistic growth over the course of the trimester.

On Friday, April 1, the fourth-grade beginner band held their first concert for their families. The third-grade class attended to learn about different band instruments for next year.

On Thursday, April 7, officers from the Hoboken Police Department met with the Middle School classes to talk about cyberbullying and internet safety.

Also on Thursday, April 7, Lower School teachers participated in professional development with Sarah Wicht focused on choosing appropriate texts to explore social justice issues.

The K-8 program also participated in several field trips: the third and fourth grades visited Ellis Island; the fifth grade went to NYC to visit the tenement museum.

15. <u>Upper School Report</u>

Cougar Student Spirit continued this month. Students initiated a Cougar Represent Day, on which students dressed to represent their cultures, and a Spirit Week, complete with a door decorating contest featuring the school's mission. The Music Club sponsored a Karoake event. A Student Change Council was created to harness these leadership skills.

Spanish 1 spent time at the Hoboken Community Center Pantry. The Junior College and Career elective visited Stevens University, meeting with admission and touring the campus. Many Seniors have received additional college acceptances- see below for an updated list!

Marking Period 3 ended April 8th. New electives will begin after the April break and include Senior Project Seminar, Queer History of Theater, Words in Art, Joy in Resistance, and Urban Gardening.

Hoboken Charter School provided the SAT free to all 11th graders during the school day to ease access to this important test.
